



**World-class asset strategically located to capitalise on growth in SE Asia gas demand**


## Technical Highlights:

- ✓ Lies in heart of prolific gas fairway
- ✓ Shallow water, good reservoir quality
- ✓ Discovered by Shell in 1998
- ✓ Gas encountered at 2,890m subsea
- ✓ Reprocessed 3D seismic data images field for first time
- ✓ >3 Tcf of combined contingent and prospective gas resources
- ✓ Appraisal drilling and testing in H1 2026

- ✓ Simple phased development concept
- ✓ Highly productive gas reservoirs
- ✓ Multiple development funding options


